

# **National Council of Corvette Clubs, West Region**

## ***Summary of West Region Business from March-December 2020***

**April 14, 2021**

Since the West Region has had no in-person meetings since February 20, 2020, there have been no meeting minutes to report to the members. The Region has conducted all necessary business required by the By-Laws and/or Operating Rules and Procedures by some electronic/phone method throughout this period. Below is a general recap of activity that has occurred in the Region from March 2020 through December 2020.

The Balance Sheet and Profit & Loss statements ending June 30, 2020, October 31, 2020 and December 31, 2020 compiled by Jay Hommer, West Region Treasurer, were sent by the RE to all regional officers and Governors via email.

Officer nominations for calendar year 2021 and subsequent voting was done electronically. Based on the results of the voting, the West Region officers for 2021 are:

The Operating Rules and Procedures and the By-Laws were reviewed by a Committee assigned by the RE on March 6, 2020. The updated Operating Rules and Procedures were emailed to all officers and Governors by the Secretary, Linda Hommer, on September 10, 2020. There were no comments or objections received, so the Operating Rules and Procedures were approved. They are currently on the West Region website. On September 10, 2020, the Governors were informed by email that the proposed changes to the By-Laws were on the West Region website for their review and comment. On January 31, 2021, the proposed By-Laws were sent to all Governors via email by Gene Gau, RE, for final review, comment and vote. Gene Gau, RE, stated in an email on February 20, 2021 that the By-Law revisions were approved by the Governors. The By-Laws are currently on the West Region website.

Gene Gau, RE, acquired two \$50 Echler's gift certificates from NCCC Charity Director. A random drawing among all West Region members was done on December 16, 2020 by "Honest Abe Lincoln" Kathy Gau. Lyle Eckberg and Garland Groom were the two lucky winners of the gift certificates – Congrats!

All clubs had paid their West Region dues by November 23, 2020. The Region did lose one club, River City Corvette Association, located in Burlington, IA.

The Scholarship committee met and recommended two applicants for West Region scholarships. Based on the Scholarship Committee reviews, the Region awarded a \$500 scholarship to Iowa State University in the name of Madeline Pagel and a \$500 scholarship to University of Nebraska in the name of Sarah Reade on October 19, 2020. Congratulations to both applicants!
